At Alexandria Field (N85) the emphasis has always been on developing pilots. Since Bill Fritsche carved the first runway out of a cornfield in 1944, Alexandria Field has focused on teaching people to fly for both career opportunities and the freedom of personal flying.

Bill's daughter, Linda Fritsche Castner manages the airport today with her husband Corky and brother Bill and is the President of Up, Up, And Away In Hunterdon, Inc. the corporation which developed the "Cleared for Takeoff" camp curriculum.

Ms. Castner is a licensed Private Pilot, an Advanced Ground Instructor, and a second-generation airport owner/operator. She received her formal education as a teacher, with a B.S. in Health and Physical Education from the University of Bridgeport, and a Master's Degree in Exercise Physiology from Smith College. While Linda is the primary camp instructor she utilizes Certified Flight Instructors (CFI) from N85's flight school and several highly motivated aircraft owners who hangar their planes on the field for added expertise with hands-on activities.

While the overall purpose of the day camp is to provide participants with opportunities to explore the wide variety of content areas required to become a private pilot, it is also interested in providing a personal growth experience. Activities are structured to encourage the development of confidence, leadership, and the ability to contribute to a group learning experience. The "Living Laboratory" allows students to be curious about careers in transportation. It integrates science, technology, engineering, and math (STEM) problems in a hands-on manor and motivates students to address these types of challenges in an experiential, fun environment.

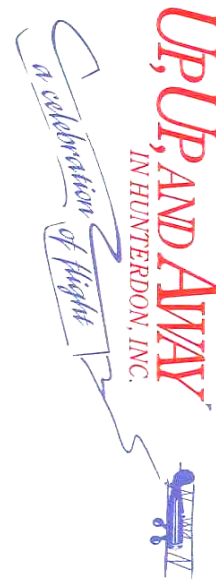
DAILY SCHEDULE

I understand and certify that my child's participation in The "Cleared for Takeoff" Aviation Education program at Alexandria Field airport and its activities (on or off the airport proper) is completely voluntary and I have familiarized myself with the program and activities in which my child will be participating.

I recognize that certain hazards and dangers are inherent in an aviation program environment particularly, but not limited to: aspects, conditions, and factors involved in boarding, flying and landing aircraft that may expose my child to inherent dangers. Some but not all of these dangers involve: contact with the propeller, injuries derived from engine failure and contact with debris thrown from the propeller back wash. There is possibility of minor or severe injury, and in some cases death from injuries. I also recognize that the basic nature of the ground instruction involves interactive activities used to bring the science of flight to life. Some, but not all of these dangers involve: the building of rockets, balloons, kites and model aircraft and then flying them.

I acknowledge that although Up, Up, And Away In Hunterdon, Inc. (UUAH) – Cleared for Takeoff program managers have taken safety measures to minimize the risk of injury to program participants, UUAH cannot insure nor guarantee that the participants, equipment, premises and/or activities will be free of hazards, accidents and/or injuries. I recognize these inherent risks and understand that I have assumed these risks by enrolling my child. Furthermore, I have instructed my child in the importance of knowing and abiding by the program rules, regulations and procedures for the safety of other participants and we both agree to do so.

Furthermore, the undersigned acknowledge that they are the parents or legal guardian of the above minor child participating in the "Cleared for Takeoff" Aviation Education program at Alexandria Field airport. Directions to Alexandria Field Airport

From the North/East/Northeast/NYC:

Route 287, the Garden State Parkway, Route 22 or the NJ Turnpike to Interstate 78 West. Interstate 78 West to Exit 12. Left at the end of the exit. Left at the traffic light. Follow 625 to Airport Road on the Right. Look for Airport entrance signs.

SW Jersey/Trenton/Phila. Area:

I-95 North to Rt. 29 North to Frenchtown. Right onto Rt. 513 out of Frenchtown (towards Pittstown). After Everittstown turn left on 625 North to Airport Rd. on left. West: Interstate 78 East to Exit 12. Left at the end of the ramp, then right at light. Follow North/East directions.
